

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family**  
**Assistance – FY13 Food Distribution Program Nutrition Education Budget**  
**Amendment #1 Account No. 500-13-6332)**

**RESOLUTION NO. 13-260**

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**  
2 **Assistance Division, Food Distribution Program under an FY2013 grant with the United**  
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**  
5 **(commodity foods) and nutrition education to eligible households through tailgate**  
6 **distribution system throughout the Nation and nearby towns; and**

7 **WHEREAS, by Resolution Number 12-217 the Tohono O'odham Legislative Council approved the**  
8 **FY2013 Food Distribution Program, Nutrition Education budget in the amount of**  
9 **\$1,800.00; and**

10 **WHEREAS, the Tohono O'odham Nation was notified of the final grant award for the FY2013 USDA**  
11 **Food Distribution Program, Nutrition Education budget in the amount of \$1,999.00;**  
12 **and**

13 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
14 **Division, Food Distribution Program has prepared the attached FY2013 Nutrition**  
15 **Education budget amendment #1 which decreases line items 7005 Supplies Other;**  
16 **adds a new line item 7010 Program Supplies and increases 9000 Indirect Cost to from**  
17 **18.82% to 18.43%; and**

18 **WHEREAS, the Health and Human Services committee and the Budget and Finance committee**  
19 **of the Legislative Council have reviewed this budget amendment and recommend its**  
20 **approval and adoption.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
22 **authorizes the expenditure of the FY2013 Food Distribution Nutrition Education**  
23 **budget Amendment #1**

- 24 **1. Decreases as operational line item.**
- 25 **2. Creates new line item.**
- 26 **3. Indirect Cost adjust to the current rate from 18.82% to 18.43%.**
- 27 **4. Increase to total budget amount from \$1,800 to \$1,999.**

7 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
8 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
9 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
10 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
11 **Stat. 984).**


