5	Juvenile Court and will suspend her legal practice prior to the expiration of the Fiscal
6	Year 2013 Attorney Contract; and
7	WHEREAS, the Office of Attorney General continues to require the legal services of outside
8	counsel to represent the Tohono O'odham Nation in legal proceedings in Maricopa
9	County, Arizona, involving the Nation's interests under the Indian Child Welfare Act
10	and
11	WHEREAS, the Attorney General recommends that the Fiscal Year 2013 Attorney Contract with
12	Kerstin G. LeMaire be assigned to and assumed by Ed Johnson; and
13	WHEREAS, the Domestic Affairs Committee has reviewed the Assignment and Assumption
14	Agreement For Attorney Contract in FY2013 and recommends approval by the
15	Legislative Council.
16	NOW, THEREFORE, BE IT RESOLVED THAT:
17	1. The Tohono O'odham Legislative Council approves the Assignment and
18	Assumption Agreement For Attorney Contract in FY2013, substantially in the form
19	attached hereto.
20	2. The Chairperson of the Nation is authorized to execute the Assignment and
21	Assumption Agreement.
