LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Setting July 18, 2013 Special Session to Address the District Allocations)

LEGISLATIVE ORDER NO. 13-263

1	WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2	regulate all meetings of the Tohono O'odham Council, standing committees, boards
3	and special committees." (Constitution of the Tohono O'odham Nation, Article VI,
4	Section 1(a)); and
5	WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with
6	the authority to "by majority vote, call for a special session" (Legislative Rules of the
7	Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and
8	WHEREAS, 26 T.O.C. Chapter 1, Article 3, the Gaming Revenue Distribution Formula and District
9	Allocation Guidelines, establish a formula and requirements for allocating a portion
10	of the Nation's gaming revenues to the Nation's districts; and
11	WHEREAS, "Annually, on August 1, the District Allocation (as that term is used in Article 3 of this
12	Chapter) shall be apportioned to the separate District accounts in accordance with the
13	allocation formula established by the Legislative Council and shall be made available
14	for expenditure subject to" approved budgets, annual audits, internal controls, and
15	other requirements (26 T.O.C. Chapter 1, Article 3, Sections 1304-1306); and
16	WHEREAS, the Budget and Finance Committee has requested a special session on July 18, 2013 to
17	address the District Allocation and other financial issues.
18	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a
19	special session on July 18, 2013 to address the District Allocation and other financial
20	issues.
