RESOLUTION NO. 13-265

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative
2		Council with legislative and fiscal powers, including the power "to manage any funds
3		within the exclusive control of the Tohono O'odham Nation, including proceeds
4		derived from lands and resources of the Tohono O'odham Nation" (Constitution,
5		Article VI, Section 1(d)(2)); and
6	WHEREAS,	the Legislative Council has adopted a formula for distributing the Nation's gaming
7		revenues ("Formula"), which includes an allocation to the Nation's districts ("District
8		Allocation") (26 Tohono O'odham Code Chapter 1, Article 3 Section 1301); and
9	WHEREAS,	annually on August 1 the District Allocation is apportioned to the separate District
10		accounts in accordance with the allocation formula established by the Legislative
11		Council (26 Tohono O'odham Code Chapter 1, Article 3, Section 1304); and
12	WHEREAS,	the Formula provides that 15% of the District Allocation shall be allocated to the
13		District where the Gaming Facility which generated such revenue is located (the "Host
14		District Share ") and that the remainder of the District Allocation be divided among all
15		districts in accordance with the allocation formula established by the Legislative
16		Council (26 Tohono O'odham Code Chapter 1, Article 3, Section 1301(B)(2)(a) and (b),
17	:	Section 1304); and
18	WHEREAS,	the Legislative Budget and Finance Committee has discussed three options for
19	1	dividing the remainder of the FY 2014 District Allocation by (1) equal distribution, (2)
20		population distribution, or (3) 50/50 distribution (1/2 equal and 1/2 population); and
21	WHEREAS,	the Tohono O'odham Nation Office of the Treasurer has calculated the FY 2014 District
22	,	Allocation in accordance with the FY 2014 District Allocation Table, which is
23	i	incorporated by this reference.
24	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves
25		and authorizes the allocation of the FY 2014 Host District Share and the remainder of
26	1	the FY 2014 District Allocation among the 12 Districts of the Nation by equal
27		distribution effective August 1, 2013 in accordance with the FY 2014 District Allocation
