8	WHEREAS, Amendment No. 2 will add Line Item (750) Major Equipment for \$238,513.00 to allow
9	the Sif-Oidak District to purchase $12\mathrm{computers}$ , $3\mathrm{fifteen}$ passenger vans and $2\mathrm{storage}$
10	bins for the District Administration; and
11	WHEREAS, the Legislative Budget and Finance Committee did review the FY 2013 Community
12	Services Budget No. 2 on July 17, 2013 and recommends approval.
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council, that it does
14	hereby approve the FY 2013 Sif-Oidak District Community Services Budget
15	Amendment No. 2 in the amount of \$238,513.00. (Attached hereto)
16	BE IT FURTHER RESOLVED that the funding amount of \$238,513.00 will be distributed from the
17	Mining Funds held by the Tohono O'odham Nation Treasury on behalf of the Sif-Oidak
18	District.
19	BE IT FURTHER RESOLVED that the funding amount will increase the Community Services Budget
20	from \$583,750.00 to a new total of \$822,263.00.
21	BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding
22	levels that it shall be approved by the Tohono O'odham Legislative Council prior to any
23	expenditures.
24	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $18^{ m TH}$ Day
25	of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-AGAINST;
26	-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
27	Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono

29	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
