

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the 2013 NRD-WVMP-USFWS Budget Amendment No. 1, Account 700-13-3577)**

**RESOLUTION NO. 13-269**

1 **WHEREAS, Resolution No. 10-368 approved and accepted the U.S. Fish and Wildlife Services'**  
2 **Tribal Wildlife Grant Award No. AZ U-10-NA-1 in the amount of \$200,000 to inventory**  
3 **the flora and fauna in the Coyote, Quinlan and Baboquivari Mountains, otherwise**  
4 **known as the Baboquivari Mountain Region; and**

5 **WHEREAS, Resolution No. 12-234 approved the FY 2013 NRD-WVMP-USFWS budget for a total**  
6 **budget of \$72,393.52; and**

7 **WHEREAS, the Wildlife and Vegetation Management Program has prepared the attached FY 2013**  
8 **Budget Amendment No. 1 to decrease line items 7000-Office Supplies, 7005-Office**  
9 **Equipment and 7110-Communication Expense and increase line item 7010-Program**  
10 **Supplies; and**

11 **WHEREAS, amendment #1 is allowing the creating of line item 7400-RM Equipment to be added**  
12 **to the FY 2013 NRD-WVMP-USFWS Budget; and**

13 **WHEREAS, the indirect cost (Grant Support) rate is calculated at 18.43% decreasing the rate from**  
14 **18.82% in accordance with the Nation's approved IDC rate changing the amount of**  
15 **indirect cost also to be added to the FY 2013 NRD-WVMP-USFWS Budget changing the**  
16 **total budget amount; and**

17 **WHEREAS, the Agriculture and Natural Resources Committee and the Budget and Finance**  
18 **Committee have reviewed this Budget and recommend its approval by the Legislative**  
19 **Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
21 **Amendment No. 1 in accordance with the budget attached here:**

- 22 **1. To create line item 7400-RM Equipment**
- 23 **2. To increase and decrease operational expense line items**
- 24 **3. To adjust the Indirect Cost Rate from 18.82% to 18.43%**
- 25 **4. Changing total budget amount from \$72,393.52 to \$72,155.91**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
27 **Chairperson and any designated official to expend and administer the budget, as**  
28 **attached, provided that any amendments affecting the funds or funding levels of the**  
29 **budget shall be submitted for further prior approval by the Tohono O'odham**  
30 **Legislative Council.**
