

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2013 Legislative Branch Budget Amendment No. 4)

RESOLUTION NO. 13-271

1 **WHEREAS, the Legislative Council is authorized “to manage any funds within the exclusive**
2 **control of the Tohono O’odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members” provided that “[a]ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets” authorized by resolution or**
5 **ordinance (Constitution of the Tohono O’odham Nation, Article VI, Section 1(d)(2)); and**
6 **WHEREAS, the Legislative Branch FY 2013 budget was approved by Resolution No. 12-209; and**
7 **WHEREAS, the Legislative Branch administration has prepared and submitted for review and**
8 **approval its FY 2013 Budget Amendment No. 4 in the amount of \$80,120.00 to increase**
9 **line items 6005-Occasional Appointments by \$6,000.00; 7000-Supplies – Office by**
10 **\$4,880.00; 7005-Supplies Office Equipment by \$5,000.00; 7060-Food by \$10,000.00; 7075-**
11 **Fuel by \$8,000.00; 7110-Communication Expenses by \$7,000.00; 7305-General Liability**
12 **Insurance by \$5,000.00; 7340-Public Relations by \$10,000.00; 7355-Professional**
13 **Services by \$13,000.00; 7365-Committee Fees by 7,000.00; 7400-RM Equipment by**
14 **\$5,000.00; and 7615-Donation/Contribution by \$5,240.00; and**
15 **WHEREAS, the FY 2013 Legislative Branch Budget Amendment No. 4 has sufficient funds in the**
16 **Legislative Branch FY 13 budget to support the proposed Legislative Branch FY 2013**
17 **Budget Amendment No. 4; and**
18 **WHEREAS, the Legislative Branch FY 2013 Budget Amendment No. 4 has been reviewed by the**
19 **Budget and Finance Committee & Recommends approval.**
20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby approves**
21 **the FY 2013 Legislative Branch Budget Amendment No. 4, Attached hereto.**
22 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council that the Tohono O’odham**
23 **Nation Legislative Council Chairman and Vice-Chairman are authorized to administer**
24 **the attached budget, provided however, that any amendments affecting these funds**
25 **or funding levels budgeted shall be submitted for prior approval by the Tohono**
26 **O’odham Legislative Council.**
