1	WHEREAS, on Saturday, May 25, 2013 the Tohono O'odham Election Board conducted a general
2	election for the offices of representatives and alternates to the Tohono O'odham
3	Legislative Council and, in a first election of the newly created Hia-Ced District, an
4	election for the offices of the Hia-Ced District chairperson, vice-chairperson, and
5	representatives and alternates to the Tohono O'odham Legislative Council and Hia-
6	Ced District Council; and
7	WHEREAS, the Election Board issued its Certificate of Election Results for the May 25, 2013
8	general election in accordance with Section 6.K. of Article VII of the Uniform Election
9	Ordinance, Ordinance No. 03-86, and by Legislative Order No. 13-207 the Legislative
10	Council issued Certificates of Election to the candidates receiving the highest number
11	of votes for each office of the Legislative Council and Hia-Ced District Council and
12	seated such persons; and
13	WHEREAS, the May 25, 2013 general election resulted in a tie between two candidates for the
14	office of Hia-Ced District Council "Representative 5," and on June 22, 2013 the Election
15	Board conducted a run-off election in accordance with Article VII, Section 6.M. of the
16	Uniform Election Ordinance; and
17	WHEREAS, the Election Board has issued its Certificate of Election Results dated June 22, 2013
18	declaring candidate Brenda Lee Faville as having received the highest number of votes
19	for the office of Hia-Ced District Council "Representative 5," and candidate Melvin
20	Ortega as having received the highest number of votes for the office of Hia-Ced District
21	Council "Alternate 1" to serve as alternate to Representative Delfina Cameron; and
22	WHEREAS, in the "first election of the Hia-Ced District Council," the Legislative Council is
23	required to issue Certificates of Election to the person who received the highest
24	number of votes for each office on the Hia-Ced District Council and to seat such
25	persons (27 T.O.C. Chapter 1, Section 1106(B) and 2013 Hia-Ced District Election Plan).
26	NOW, THEREFORE, BE IT ORDERED that the chairperson and secretary of the Tohono O'odham
27	Legislative Council are authorized and directed on behalf of the Legislative Council
28	to execute and deliver a Certificate of Election to each of the following persons elected
29	as representative and alternate to the Hia-Ced District Council; provided that all such
