5	building at the Health and Human Services Complex off Highway 86 at approximately
6	milepost 113; and
7	WHEREAS, the purpose of the Lease Agreement is for Lessee to operate and maintain a dialysis
8	clinic; and
9	WHEREAS, the Lease Agreement provides that the Lessee can rent additional space for additional
10	dialysis stations upon 10-days written notice to the Nation; and
11	WHEREAS, Lessee has proposed a ``First Amendment to Lease Agreement'' to rent additional space
12	$for four additional \ dialysis \ stations, as well \ as \ various \ other \ amendments \ to \ the \ terms$
13	of the Lease Agreement, including an increase in rent for the additional space; and
14	WHEREAS, the Commerce and Health and Human Services Committees have reviewed the
15	proposed First Amendment to Lease Agreement and recommend Legislative Council
16	approval.
17	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18	First Amendment to Lease Agreement between the Nation and DVA Renal Healthcare
19	substantially in the form attached hereto, and authorizes the Chairman of the Nation
20	to execute it.
