8	WHEREAS, the Budget and Finance Committee has requested a July 23-26, 2013 special session to						
9	address the Nation's FY 2014 budgets and finances.						
10	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a July						
11	23-26, 2013 special session to address the Nation's FY 2014 budgets and finances.
