5	revenue projections for FY 2014; and
6	WHEREAS, the Legislative Council approved the amending of Subsections 1301 (A) and (B) of 26
7	Tohono O'odham Code Chapter 1, Article 3 - Gaming Revenue Distribution Formula
8	and District Allocation Guidelines for Fiscal Year 2014 and FY 2015 per Resolution No.
9	13-267; and
10	WHEREAS, the Nation's Treasurer has calculated that \$81,759,848.97 is needed to fund the
11	Nation's FY 2014 General Fund budgets for the Executive, Legislative and Judicial
12	Branches, including a 3% Cost of Living Adjustment (COLA); and
13	WHEREAS, the Budget and Finance Committee and the Executive Office recommend the adoption
14	of the FY 2014 General Fund Budgets per the attached FY 2014 Revenue Projections.
15	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
16	approves the FY 2014 revenue projections in the amount of \$81,759,848.97 for the
17	purpose of funding the FY 2014 General Fund budgets, including a 3% Cost of Living
18	Adjustment (COLA), of the Tohono O'odham Nation.
