Appropriating the Amount of \$71,825,358.47)**

RESOLUTION NO. 13-277

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2014 Tribal Budgets**  
2 **to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Executive Branch Fiscal Year 2014 Budget for the period beginning October 01,**  
4 **2013 ending September 30, 2014 has been reviewed by the Budget and Finance**  
5 **Committee and presented to the Legislative Council both in Summary as Schedule A**  
6 **as well as in detailed Budgets collectively ("Executive Branch FY 2014 Budgets") that**  
7 **by this reference are all incorporated into this Resolution.**


8 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby adopt, approve and**  
9 **appropriates \$71,825,358.47 from General Fund Revenues to fund the Executive**  
10 **Branch Fiscal Year 2014 Budget, which is approved.**

11 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
12 **the expenditure of funds appropriated to and in accordance with the Executive Branch**  
13 **FY 2014 Budget for the period beginning October 01, 2013 ending September 30, 2014.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Chairperson and any designated official to expend and administer the budget as**  
16 **attached, provided that any amendments affecting the funds or funding level is**  
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>rd</sup> Day**  
19 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0-AGAINST;**  
20 **-0- NOT VOTING; and 224.2[07] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
21 **Section 1 (d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
