(Approving the Fiscal Year 2014 Budget for the Tohono O'odham Nation Justice Center and Appropriating Funds in the amount of \$6,203,879.25)

RESOLUTION NO. 13-278

WHEREAS, the Fiscal Year ("FY") 2013 will end at midnight, September 30, 2013 and all spending
authority granted under the FY 2013 budgets will terminate at that time; and
WHEREAS, the Judicial Branch of the Tohono O'odham Nation has prepared and presented a
budget to the Tohono O'odham Legislative Council ("Legislative Council") that reflects
the needs of the Branch for the 2014 fiscal year, a copy of the proposed said budget is
attached hereto and incorporated herein by reference; and
WHEREAS, the proposed FY 2014 Judicial Branch budget includes personnel expenses in the
amount of \$5,691,012.92 and operational costs in the amount of \$512,866.33, totaling
\$6,203,879.25; and
WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative
Council have reviewed this budget and recommend its approval and adoption.
NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council has reviewed and
approves the Fiscal Year 2014 budget for the Tohono O'odham Judicial Branch in the
amount of \$6,203,879.25.
BE IT FURTHER RESOLVED that funds in the amount of \$6,203,879.25 is appropriated from the
general funds and authorized to be expended for Fiscal Year 2014 budget of the
Tohono Oʻodham Judicial Branch.
BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
Chief Judge and any designated official to expend and administer the budget as
attached, provided that any amendments affecting the funds or funding level shall be
submitted for further prior approval by the Tohono O'odham Legislative Council.
The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24 TH Day of <u>IULY</u> , 2013 at a meeting at which a quorum was present with a vote of <u>2,722.3</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>224.2[07]</u> ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (<u>d)(2)</u> of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
