

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2014 Budget for the Tohono O'odham Nation Justice
Center and Appropriating Funds in the amount of \$6,203,879.25)

RESOLUTION NO. 13-278

1 **WHEREAS, the Fiscal Year ("FY") 2013 will end at midnight, September 30, 2013 and all spending**
2 **authority granted under the FY 2013 budgets will terminate at that time; and**

3 **WHEREAS, the Judicial Branch of the Tohono O'odham Nation has prepared and presented a**
4 **budget to the Tohono O'odham Legislative Council ("Legislative Council") that reflects**
5 **the needs of the Branch for the 2014 fiscal year, a copy of the proposed said budget is**
6 **attached hereto and incorporated herein by reference; and**

7 **WHEREAS, the proposed FY 2014 Judicial Branch budget includes personnel expenses in the**
8 **amount of \$5,691,012.92 and operational costs in the amount of \$512,866.33, totaling**
9 **\$6,203,879.25; and**

10 **WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative**
11 **Council have reviewed this budget and recommend its approval and adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council has reviewed and**
13 **approves the Fiscal Year 2014 budget for the Tohono O'odham Judicial Branch in the**
14 **amount of \$6,203,879.25.**

15 **BE IT FURTHER RESOLVED that funds in the amount of \$6,203,879.25 is appropriated from the**
16 **general funds and authorized to be expended for Fiscal Year 2014 budget of the**
17 **Tohono O'odham Judicial Branch.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chief Judge and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall be**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
23 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and 224.2[07] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
26 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
27 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




