

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Legislative Branch FY 2014 Budget)**

RESOLUTION NO. 13-279

1 WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the  
2 authority "to manage any funds within the exclusive control of the Tohono O'odham  
3 Nation ... and to appropriate these funds for the benefit of the Nation and its members  
4 "provided that" [a]ll expenditures of these funds shall be pursuant to appropriations  
5 or budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY 2014  
8 Legislative Branch Budget, which is incorporated by this reference; and

9 WHEREAS, the Legislative Branch is including the funding of the twelfth political district  
10 Legislative Representatives, Salaries & supporting costs to its proposed budget; and

11 WHEREAS, the Legislative Branch distributed a courtesy copy of the FY 2014 Legislative Branch  
12 Budget to all Councilmembers, Staff and all Districts, and

13 WHEREAS, the FY 2014 proposed budget was presented & reviewed by Budget and Finance  
14 Committee of the Legislative Council and recommends its approval.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
16 and authorizes expenditure of the FY 2014 Legislative Branch Budget in the amount  
17 of \$3,730,611.25, as per the attached budget, beginning October 1, 2013 and ending  
18 September 30, 2014.

19 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
20 Chairperson and any designated official to expend and administer the Budget as  
21 attached, provided that any Amendments affecting the funds or funding level is  
22 submitted for further prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day  
24 of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0- AGAINST;  
25 -0- NOT VOTING; and 224.2[06] ABSENT, pursuant to the powers vested in the Council by Article VI,  
26 Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
27 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
28 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
