1 **WHEREAS, the Water Resources Department was awarded an Environmental Protection Agency**
2 **106 grant, in the amount of \$135,000.00; and**

3 **WHEREAS, the Water Resources Department is requesting the authority to accept and expend the**
4 **106 grant for the FY2014 budget; and**

5 **WHEREAS, the Water Resources Department is requesting an in-kind service match of \$7,105.00**
6 **from the Water Resources Department FY2014 budget; and**

7 **WHEREAS, the Water Resources Committee and the Budget and Finance Committee of the**
8 **Legislative Council have reviewed this Budget and recommend its approval and**
9 **adoption.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the budget for Environmental Protection Agency 106 grant, in the amount of**
12 **\$135,000.00, and an in-kind service match of \$7,105.00 from the Water Resources**
13 **Department FY 2014 budget.**

14 **BE IT FURTHER RESOLVED that the Legislative Council approves the attached FY 2014 budget**
15 **which does not include IDC and authorizes the expenditure of funds according to this**
16 **budget which shall be in effect from October 1, 2013 to September 30, 2014.**

17 **BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairman or their designee**
18 **to seek reimbursement or recoup any indirect cost expenses in the event an indirect**
19 **cost rate is subsequently approved by the National Business Center.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the Budget, as**
22 **attached, provided that any Amendments affecting the funds or funding level is**
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
25 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and 224.2[07] ABSENT, pursuant to the powers vested in the Council by Article VI,**
27 **Section 1 (d)(2)(3) and (f) and Article XVII of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
30 **of June 18, 1934 (48 Stat. 984).**
