

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 13-284, "Authorizing the appropriation and expenditure of \$1,916,982.56 from the Southern Arizona Water Rights Settlement Act Trust Fund for the Water Resources Department FY2014 SAWRSA budget and an in-kind service match of \$7,105.00 from the FY2014 SAWRSA Budget to the Water Resources Department FY 2014 EPA budget")**

**RESOLUTION NO. 13-285**

1 **WHEREAS, the Water Resources Department is requesting \$1,916,982.56 from the Southern**  
2 **Arizona Water Rights Settlement Act Trust Fund for the FY2014 budget; and**

3 **WHEREAS, the Water Resources Department is also requesting an in-kind service match of**  
4 **\$7,105.00 from the FY2014 SAWRSA budget for the Water Resources Department**  
5 **FY2014 EPA budget; and**

6 **WHEREAS, the Water Resources Committee and the Budget and Finance Committee of the**  
7 **Legislative Council have reviewed this Budget and recommend its approval and**  
8 **adoption.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **authorizes:**

11 **1. The appropriation and expenditure of \$1,916,982.56 from the Southern Arizona**  
12 **Water Rights Settlement Act Trust Fund for the Water Resources Department**  
13 **FY2014 budget, in accordance with the budget attached hereto.**

14 **2. An in-kind service match of \$7,105.00 from the FY 2014 SAWRSA budget to the**  
15 **Water Resources Department FY2014 EPA budget.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the Budget, as**  
18 **attached, provided that any Amendments affecting the funds or funding level is**  
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
21 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and 224.2[08] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
23 **Section 1 (f)(i) and Article XVII of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**


