

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Acceptance of the Clean Air Act FY2014 Budget)**

**RESOLUTION NO. 13-288**

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the environment and**  
2 **safe guarding the health and well-being of the Nation's members; and**

3 **WHEREAS, the Tohono O'odham Nation Environmental Protection Office (EPO) has submitted a**  
4 **proposal to the U.S. Environmental Protection Agency under the Clean Air Act (CAA)**  
5 **Grant in the amount of \$75,000.00 for continued funding which will be awarded in an**  
6 **Assistance Agreement; and**

7 **WHEREAS, the Clean Air Act grant would allow the Nation to update the Point Source Emissions**  
8 **Inventory and Needs Assessment, implement a Monitoring Plan; conduct Air Toxic and**  
9 **Particulate Matter (PM10) Monitoring and participation in local, regional and national**  
10 **initiatives; and**

11 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**  
12 **Legislative Council have reviewed this Budget and recommend its approval and**  
13 **adoption; and**

14 **WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged without**  
15 **a current year IDC agreement.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
17 **the FY 2014 Budget in the amount of \$75,000.00 and to utilize the Nations resources**  
18 **pending reimbursement from the Grantor for the continued funding of the grant.**

19 **BE IT FURTHER RESOLVED that the Legislative Council approves the attached FY 2014 budget**  
20 **which does not include IDC and authorizes the expenditure of funds according to this**  
21 **budget which shall be in effect from October 1, 2013 to September 30, 2014.**

22 **BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairman or their designee**  
23 **to seek reimbursement or recoup any indirect cost expenses in the event an indirect**  
24 **cost rate is subsequently approved by the National Business Center.**


25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level shall be**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


