

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Tribal Employment Rights Office FY - 2014**  
**TERO/EEOC Budget)**

**RESOLUTION NO. 13-289**

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**  
2 **1978; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is to increase**  
4 **employment of Indians on and near the Tohono O'odham Nation by enforcing Indian**  
5 **Preference in employment, training, contracting, subcontracting and eradicate**  
6 **employment discrimination within the exterior boundaries of the Tohono O'odham**  
7 **Nation; and**

8 **WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office has been**  
9 **supplemented by the Equal Employment Opportunity Commission in the amount of**  
10 **\$35,494.05; and**


11 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**  
12 **Legislative Council have reviewed this Budget and recommend its approval and**  
13 **adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby accepts the**  
15 **FY 2014 Budget in the amount of \$35,494.05 and to utilize the Nation's resources**  
16 **pending reimbursement from the Grantor for the continued funding of the contract.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**  
18 **the Chairperson and any designated official to expend and administer the budget as**  
19 **attached, provided that any amendments affecting the funds or funding level shall be**  
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
23 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0- AGAINST;**  
24 **-0- NOT VOTING; and 224.2[07] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
25 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
