17	WHEREAS,	the Tohono O'odham Nation has received notice from CPB that KOHN will continue to
18		be funded at similar levels for succeeding fiscal years so long as it maintains its
19		eligibility; and
20	WHEREAS,	each grant award has an expenditure period of two years, the 2014 grant amount will
21		have a grant period of October 1, 2013 through September 30, 2015, however, KOHN
22		budgets the full amount for the current fiscal year of October 1, 2013 through
23		September 30, 2014 and intends to re-submit to the legislative council for approval the legis
24		carry forward of any funding that remains unexpended at fiscal year-end 2014; and
25	WHEREAS,	the Culture Preservation Committee and the Budget and Finance Committee of
26		Legislative Council have reviewed this budget and recommend its approval and
27		adoption.
