11	WHEREAS,	the Agricultural and Natural Resources Committee and the Legislative Budget and
12		Finance Committee of the Legislative Council have reviewed the Budget and
13		recommend its approval and adoption.
14	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council: authorizes the
15		expenditure of \$1,939,480.84 which is a combination of \$410,000.00 from Solid Waste
16		Management Program Revenue and \$1,529,480.84 from General Fund per Resolution
17		#13-277 for a Budget period of October 1, 2013 through September 30, 2014.
18	BE IT FINAI	LLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
19		Chairperson and any designated official to expend and administer the Budget as
20		attached, provided that any Amendments affecting the funds or funding level is
21 22		submitted for further prior approval by the Tohono O'odham Legislative Council.
