7	funds from the I.H.S. grant ended on August 31, 1990; and
8	WHEREAS, pursuant to Legislative Council Resolution No. 99-500, the Department of Health and
9	Human Services, Division of Behavioral Health, SMI Program has been collecting third
10	party reimbursement funds since September 1999 from the State of Arizona and has
11	since accumulated funds; and
12	WHEREAS, the Division of Behavioral Health, has accumulated funds to cover the Third Party
13	Revenue Budget Account No. 018-14-6240 in the amount of \$667,688.00 for FY2014
14	personnel, operational expenses and capital expenses (October, 01 2013 to September
15	30, 2014); and
16	WHEREAS, the Department of Health and Human Services, Behavioral Health Division request to
17	purchase an additional modular building for the SMI Program due to an increase of
18	clients; and
19	WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee
20	of the Legislative Council have reviewed this budget and recommend its approval and
21	adoption.
22	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:
23	1. The attached FY 2014 Third Party Revenue Budget in the amount of \$667,688.00 to
24	supplement the FY2014 Department of Health and Human Services, Division of
25	Behavioral Health Budget is hereby approved to expend such funds.
26	2. Add new cost share amount for the Program Development Manager position at
27	20%; Transit Driver; Peer Specialist; and Counselor Aide plus fringe benefits for all
