1	WHEREAS, the Tohono O'odham Nation continues to provide non-emergency medically necessary
2	transportation to members and residents of the Nation, and collecting third party
3	reimbursements where applicable; and
4	WHEREAS, the Tohono O'odham Legislative Council Resolution No. 04-639 authorized all third
5	party reimbursement funds collected by the Division of Health Transportation Service
6	to supplement the Division's base budget for operations; and
7	WHEREAS, there is a need to supplement the FY 2014 Tribal budget with Third Party Revenue
8	funds for operational costs such as to purchase vehicles and support additional staff
9	and
10	WHEREAS, the Health and Human Services Committee and Budget and Finance Committee of the
11	Legislative Council have reviewed the Budget and recommend its approval and
12	adoption.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
14	1. Approves the attached FY 2014 Third Party Revenue Budget in the amount of
15	\$2,738,628.00 to supplement the FY 2014 Health Transportation Service budget.
16	2. Authorizes that all Third Party revenue funds shall be utilized to supplement the
17	Health Transportation Service Tribal budgets.
18	3. Authorizes Health Transportation to expend the funds in the dedicated revenue
19	account for personnel, operational and major capital purchases.
20	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
21	Chairperson and any designated official to expend and administer the budget as
22	attached, provided that any amendments affecting the funds or funding level is
23	submitted for further prior approval by the Tohono O'odham Legislative Council.
24	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>25<sup>TH</sup></u> Day
25	of <u>IULY, 2013</u> at a meeting at which a quorum was present with a vote of <u>2,946.5</u> FOR; <u>-0-</u> AGAINST
26	[01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI
27	Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
28	O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary
