12	NOW, THEREFORE ,BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
13	authorizes the FY2014 Food Distribution Program budget in the amount of \$251,985.00
14	in accordance with the attached budget and to utilize the Nation's resources pending
15	reimbursement from the Grantor for the continuation of this Grant.
16	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
17	Chairperson and any designated official to expend and administer the budget as
18	attached, provided that any amendments affecting the funds or funding level shall be
19	submitted for further prior approval by the Tohono O'odham Legislative Council.
