2	Assistance Division, Food Distribution Program under an FY2013 grant with the United
3	States Department of Agriculture (USDA); and
4	WHEREAS, the Food Distribution Program has been beneficial in providing food packages
5	(commodity foods) and nutrition education to eligible households through tailgate
6	runs throughout the Nation and nearby towns; and
7	WHEREAS, nutrition education funds have been made available to the Tohono O'odham Nation
8	for FY2014 through the USDA in the amount of \$1,800.00; and
9	WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee
10	of the Legislative Council have reviewed this budget and recommend its approval and
11	adoption; and
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
13	authorizes the expenditure of the FY2014 Food Distribution Nutrition Education
14	budget in the amount of \$1,800.00 in accordance with the attached budget and to
15	utilize the Nation's resources pending reimbursement from the Grantor for the
16	continuation of the Grant.
17	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
18	Chairperson and any designated official to expend and administer the budget as
19	attached, provided that any amendments affecting the funds or funding level shall be
20	submitted for further prior approval by the Tohono O'odham Legislative Council.
