1	WHEREAS, the Tohono O'odham Nation received a Special Diabetes Program for Indians (SDPI)
2	grant funded by the Indian Health Service, Division of Diabetes Treatment and
3	Prevention, with a base budget of \$1,929,827.00; and
4	WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the
5	establishment of the Community Based Diabetes Prevention Program, funded by the
6	Special Diabetes Program for Indians, authorized by the Balanced Budget Act of 1997;
7	and
8	WHEREAS, the Tohono O'odham Department of Health & Human Services, Division of Healthy
9	O'odham Promotion Program (HOPP) is requesting approval of the base FY 2014
10	budget in the amount of \$1,929,827.00, for a period of October 1, 2013 to September 30,
11	2014; and
12	WHEREAS, the Health and Human Services Committee and the Budget & Finance Committee of
13	the Legislative Council have reviewed this budget and recommend its approval and
14	adoption.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
16	approve the attached budget and authorizes the expenditure of funds according to
17	this budget in the amount of \$1,929,827.00 and to utilize the Nation's resources
18	pending reimbursement from the Grantor for the continuation of this Grant.
19	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20	Chairman and any designated official to expend and administer the budget, as
21	attached, provided that any amendments affecting the funds or funding level shall be
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
