

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Family Violence Prevention and Services Grant from U.S. Department
of Human Services Administration for Children and Families FY2014)

RESOLUTION NO. 13-304

1 **WHEREAS, prevention of injuries is priority for the Tohono O'odham Nation; and**

2 **WHEREAS, the Domestic Violence Program within the Department of Health and Human Services**
3 **Division of Prevention Services, and the Domestic Violence Coalition are working to**
4 **raise awareness of family violence and continue the development of services for**
5 **domestic violence victims and their families with a Grant period of October 1, 2013 to**
6 **September 30, 2014; and**

7 **WHEREAS, the Office of Violence Against Women Domestic Violence Grant will cost share 40% of**
8 **the Family Resource Coordinator position to allow funding of the operations in this**
9 **budget; and**


10 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
11 **of the Legislative Council have reviewed this Budget and recommend its approval and**
12 **adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the FY 2014 Budget in the amount of \$78,212.00 and to utilize the Nations resources**
15 **pending reimbursement from the Grantor for the continuation of the Grant.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level is**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
21 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
23 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
