

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Office of Violence Against Women (OVW) Domestic Violence Grant  
from the U.S. Department of Justice FY 2014)**

**RESOLUTION NO. 13-305**

- 1 **WHEREAS, prevention of injuries is priority for the Tohono O'odham Nation; and**
- 2 **WHEREAS, the Domestic Violence Program within the Department of Health and Human Services**  
3 **Division of Prevention Services, and the Domestic Violence Coalition are working to**  
4 **raise awareness of domestic violence and continue the development of services for**  
5 **domestic violence victims and the community; and**
- 6 **WHEREAS, the Tohono O'odham Nation Domestic Violence Program received an award from the**  
7 **Office of Violence Against Women (OVW) in the amount of \$300,000.00 for a three year**  
8 **grant for project period October 1, 2010 to September 30, 2013; and**
- 9 **WHEREAS, the OVW Domestic Violence had a delay in program services due to delay in hiring of**  
10 **permanent staffing which caused for a large amount of unobligated funds and Tohono**  
11 **O'odham Nation will be requesting for a no cost extension for FY 2014; and**
- 12 **WHEREAS, the Family Resource Coordinator position will be cost shared with Family Violence**  
13 **Prevention budget which will allow funding of the operations and continuation of**  
14 **services for the Domestic and Family Violence budget; and**
- 15 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
16 **of the Legislative Council have reviewed this Budget and recommend its approval and**  
17 **adoption.**
- 18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
19 **the FY 2014 Budget in the amount of \$300,000.00 pending approval of a no cost**  
20 **extension from the funding agency and to utilize the Nation's Resources pending**  
21 **reimbursement from the Grantor for the continuation of the Grant.**
- 22 **BE IT FURTHER RESOLVED should the Office of Violence Against Women Grant not receive further**  
23 **funding the Tohono O'odham Nation will not be obligated to utilize the Nation's**  
24 **resources.**
- 25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level is**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




