RESOLUTION NO. 13-306

1 **WHEREAS, the Tohono O'odham Nation's (Nation) Child Welfare Division, under the supervision**
2 **of the Department of Health and Human Services, with funds authorized and**
3 **appropriated by the Nation, conducts events for the children in the care and custody**
4 **of Child Welfare; such as an annual Christmas party, Culture Day, Spring activity and**
5 **related events; and**

6 **WHEREAS, the Child Welfare Division has solicited donations and has operated other fundraising**
7 **in order to supplement funds budgeted for the Division of Child Welfare Services and**
8 **related events; and**

9 **WHEREAS, by Resolution No. 06-771, the Tohono O'odham Legislative Council authorized the**
10 **creation of an account for the Nation's Department of Health and Human Services,**
11 **Division of Child Welfare Services to use, receive and expend any and all funds from**
12 **sponsors, donors, sales and fundraising, to supplement funds allocated by the Nation;**
13 **and**

14 **WHEREAS, the Executive Branch developed the FY 2014 Child Welfare Division Revenue Budget**
15 **attached, to be effective October 1, 2013 through September 30, 2014 and requests**
16 **authorization to expend funds over the fiscal year of FY 2014 totaling \$2,000.00 with**
17 **no indirect cost, based on historical donations and fundraising; and**

18 **WHEREAS, the Health and Human Services Committee and Budget and Finance Committee of the**
19 **Legislative Council have reviewed this budget and recommend its approval and**
20 **adoption.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
22 **approves and authorizes the Executive Branch to expend funds for the budget**
23 **attached, effective October 1, 2013 through September 30, 2014 totaling \$2,000.00 with**
24 **no indirect cost, funded by donations and fundraising.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby Authorizes**
26 **Chairman and any designated official to expend and administer the budget as**
27 **attached, provided that any budget amendments affecting the funds or funding levels**
28 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
29 **Council.**




