3	WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head
4	Start Program to provide educational, health, mental health and parent involvement
5	services to children, three to five years of age; and
6	WHEREAS, Human Resource Development Committee and the Budget and Finance Committee
7	of the Legislative Council have reviewed this Budget and recommend its approval and
8	adoption.
9	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
10	and approves the FY 2014: Head Start Program Budget - \$2,224,829.13 and Head Start
11	T&TA Budget - \$27,481.68 and to utilize the Nation's Resources pending
12	reimbursement from the Grantor for the continuation of the grants.
13	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
14	Executive Branch to expend funds for the program listed above and as attached in the
15	amount indicated, effective November 1, 2013 through October 31, 2014.

18	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
19	Chairperson and any designated official to expend and administer the Budgets as

21	submitted for further prior approval by the Tohono O'odham Legislative Council.
