

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2014 Arizona Reimbursable Budget: Child and Adult Care Food Program)**

RESOLUTION NO. 13-308

1 **WHEREAS, the Tohono O'odham Nation has historically sought reimbursement through an**
2 **agreement from the State of Arizona; and**

3 **WHEREAS, the Arizona Department of Education through the Child and Adult Care Food Program**
4 **Service Agreement provided reimbursement of funds for food costs incurred based on**
5 **the guidelines identified in the agreements; and**

6 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
7 **Committee of the Legislative Council have reviewed this Budget and recommend its**
8 **approval and adoption.**


9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
10 **the Child and Adult Care Food Program Budget in the amount of \$86,453.90 and**
11 **authorizes to expend funds for the program listed herein, effective October 1, 2013**
12 **through September 30, 2014.**

13 **BE IT FURTHER RESOLVED that the Executive Branch will seek reimbursement from the Arizona**
14 **Department of Education through the Child and Adult Care Food Program Services**
15 **Agreement, to reimburse funds for food costs incurred based on the guidelines**
16 **identified in the agreement.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the Budget as**
19 **attached, provided that any Amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
22 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,705.5 FOR; -0- AGAINST;**
23 **[01] NOT VOTING; and 241.0[06] ABSENT, pursuant to the powers vested in the Council by Article**
24 **VI, Section 1 (d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**
