

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation Vocational Rehabilitation Program
FY 2014 Budget)

RESOLUTION NO. 13-309

1 **WHEREAS, the Tohono O'odham Nation intends to submit a renewal application for a 5 year grant**
2 **period beginning October 1, 2013 to September 30, 2017, from the U.S. Department of**
3 **Education, Rehabilitation Services Administration's Section 121 (Vocational**
4 **Rehabilitation Service Projects for American Indian with Disabilities) under P.L., 102-**
5 **569 Rehabilitation Act of 1973 as amended; and**

6 **WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will**
7 **be provided to eligible enrolled members of the Tohono O'odham Nation living on or**
8 **near the Nation and other federally recognized American Indians living on the Nation**
9 **with disabilities; and**

10 **WHEREAS, the Tohono O'odham Nation will contribute the required 10% match from Department**
11 **of Education Administration budget and the General Cost Pool; and**

12 **WHEREAS, the Vocational Rehabilitation Program has developed the FY 2014 budget in amount**
13 **of \$453,437.00 beginning October 1, 2013-September 30, 2014 and is seeking approval**
14 **of the attached budget; and**

15 **WHEREAS, Human Resources Development Committee and the Budget and Finance Committee**
16 **of the Legislative Council have reviewed this Budget and recommend its approval and**
17 **adoption.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
19 **approves the Vocational Rehabilitation Program's FY 2014 budget in the amount of**
20 **\$453,437.00; the required 10% match from the Department of Education**
21 **Administration budget and in the General Cost Pool; and to utilize the Nation's**
22 **resources, pending reimbursement from the Grantor for the continuation of the**
23 **grant.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**
25 **the Chairperson and any designated official to expend and administer the budget, as**
26 **attached, provided that any amendments affecting the funds or funding levels of the**
27 **budget shall be submitted for further prior approval by the Tohono O'odham Nation**
28 **Legislative Council.**
