

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Bureau of Indian Affairs One Stop Division Master 477 Budget FY 2014)**

RESOLUTION NO. 13-310

1 **WHEREAS, the Master 477 budget administers all combined federal programs under the**
2 **Education Department One Stop Division from October 1, 2013 to September 30, 2014**
3 **in the combined amount of \$1,233,234.09 with projected allocations; and**

4 **WHEREAS, the Master 477 budget had been developed and cost shared with the Arizona**
5 **Department of Economic Security funding to promote smooth transitional services for**
6 **clients with an effective cost shared to promote de-centralized services; and**

7 **WHEREAS, the Master 477 budget will be modified when federal allocations have been received**
8 **to reflect the actual allocations; and**


9 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
10 **Committee of the Legislative Council have reviewed this Budget and recommend its**
11 **approval and adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approves and authorizes the expenditure of the FY 2014 Master 477 Budget for the**
14 **Education Department - One Stop Division effective October 1, 2013 to September 30,**
15 **2014 in the projected amount of \$1,233,234.09.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any Amendments affecting the funds or funding level is**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
21 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
23 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


