

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2014 Department of Health and Human Services Child Care and
Development Fund Budgets)**

RESOLUTION NO. 13-311

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child Care**
4 **Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**
6 **Budgets as attached and incorporated by this reference, to be effective October 1,**
7 **2013 through September 30, 2014 for the FY 2014 Child Care and Development Fund**
8 **(CCDF) in the amount of \$1,034,240.70 in the following budgets:**

- 9 **1. FY 2014 CCDF Mandatory Funds - \$649,438.70.**
- 10 **2. FY 2014 CCDF Discretionary Funds - \$384,802.00.**

11 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
12 **Committee of the Legislative Council have reviewed this FY 2014 budget and**
13 **recommend its approval and adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **the CCDF Mandatory Funds Budget, and CCDF Discretionary Funds Budget for period**
16 **October 1, 2013 through September 30, 2014 and to utilize the Nation's resources**
17 **pending reimbursement from the Grantor for the continued funding of the Grant.**

18 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for the**
19 **program listed herein:**

- 20 **1. FY 2014 CCDF Mandatory Funds - \$649,438.70.**
- 21 **2. FY 2014 CCDF Discretionary Funds - \$384,802.00.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the Budgets as**
24 **attached, provided that any Amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
27 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;**
28 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
29 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
