**(Approving Fiscal Year 2013 Sells Community Budget Amendment #2)**

RESOLUTION NO. 13-312

1 **WHEREAS, Sells District, Sells Community Resolution No. SC-106-12; Sells District Council**  
2 **Resolution No. SD-78-2012 and Tohono O'odham Legislative Council Resolution No.**  
3 **12-355 approved Sells District, Sells Community Fiscal Year 2013 Budget; and**

4 **WHEREAS, Sells Community did identify the need for additional funding in certain line items to**  
5 **cover costs; and**

6 **WHEREAS, Sells Community has prepared and acquired approvals of the attached budget**  
7 **amendment and it's justifications with Sells Community Resolution No. SC-171-13 and**  
8 **Sells District Council Resolution No. SD-69-13; and**

9 **WHEREAS, Sells Community amendment #2 will increase line items #7355 Professional Services**  
10 **by \$500.00 and #7615 Donation/Contribution by \$2,497.00; and**

11 **WHEREAS, Sells Community amendment #2 will also decrease line items #6520 Per Diem by**  
12 **\$997.00; #6530 Travel Expense by \$500.00; #7045 Animal Supplies by \$500.00; #7400 RM**  
13 **Equipment by \$500.00 and #7625 General Assistance by \$500.00.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Sells**  
15 **District, Sells Community Fiscal Year 2013 Budget Amendment #2 moving around a**  
16 **total amount of \$2,997.00.**

17 **BE IT FURTHER RESOLVED that this amendment does not affect the approved Sells Community**  
18 **Fiscal Year 2013 Budget of \$138,000.00 or the overall Sells District Fiscal Year 2013**  
19 **budgeted amount of \$1,512,757.74.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**  
21 **District Chairperson and any designated District Official to expend and administer the**  
22 **budget as attached, provided that any modifications or amendments affecting the**  
23 **funds or funding levels of the budget shall be submitted for further prior approval by**  
24 **the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup> Day**  
26 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,749.6 FOR; -0- AGAINST;**  
27 **196.9[01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
28 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
31 **Stat. 984).**
