1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**
2 **ordinances governing the enrollment and adoption of members (Article II, Sections**
3 **1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation);**
4 **and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the Enrollment**
6 **Committee is responsible for reviewing enrollment applications and making**
7 **recommendations to the Legislative Council regarding the eligibility of applicants**
8 **(Ordinance No. 05-81, as amended; 14 F.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
10 **applicants for membership contain misspellings in the names of applicants; or**
11 **incorrect roll numbers; and**

12 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos.127-83, 27-84,**
13 **184-84, 69-88, 141-88, 193-88, 303-88, 292-90, 92-163, 93-033, 94-109, 94-459, 96-004, 96-**
14 **035, 96-129, 96-182, 96-324, 96-383, 96-483, 96-514, 96-547, 97-078, 97-221, 97-256, 97-**
15 **350, 97-480, 98-034, 98-083, 98-174, 98-262, 98-357, 98-429, 99-475, 99-633, 2000-298,**
16 **2000-397, 2000-486, 02-129, 02-369, 03-193, 05-607 and 12-001 be amended to reflect**
17 **the correct name spelling or roll numbers for the individuals identified in the**
18 **Amending Enrollment Resolution List August 2013, which is incorporated by this**
19 **reference; and**

20 **WHEREAS, the Enrollment Program has further determined that a member was erroneously**
21 **approved twice for membership (member was originally approved by Resolution No.**
22 **13-109); and**

23 **WHEREAS, the Enrollment Program discovered that this same member was approved a second**
24 **time in Resolution No. 12-260; and**

25 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 12-260 be**
26 **amended to delete the member identified in the Amending Enrollment Resolution List**
