delete a member who was approved twice)

RESOLUTION NO. 13-318

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"),which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**
7 **distribution payments in accordance with the Initiative (Legislative Council**
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Trust Agreement with Wells Fargo Bank requires that a listing of all minor**
10 **beneficiaries turning 18 that month be presented to the Tohono O'odham Legislative**
11 **Council to obtain approval to distribute the trust funds to these eligible minor**
12 **members as they are no longer restricted beneficiaries; and**

13 **WHEREAS, the Tohono O'odham Legislative Council approved the minors identified on the**
14 **Monthly Age 18 Report for April 2013 who reached the age of 18 and is no longer**
15 **restricted from receiving their per capita payments in Resolution No. 13-110; and**

16 **WHEREAS, the Nation's Enrollment Office has identified a member who was also previously**
17 **approved and listed on the Monthly Age 18 Report for March 2013, which was approved**
18 **by Resolution No. 13-066, "Approving the Monthly Age 18 Report for March 2013 of**
19 **Tohono O'odham Eligible Minor Members and Authorizing Distribution of the Per**
20 **Capita Payments and Interest held in Trust on Their Behalf by Wells Fargo Bank"; and**

21 **WHEREAS, the Nation's Enrollment Office recommends that the name of the member be deleted**
22 **on the Monthly Age 18 Report April 2013.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
24 **Resolution No. 13-110, "Approving the Monthly Age 18 Report for April 2013 of Tohono**
25 **O'odham Eligible Minor Members and Authorizing Distribution of the Per Capita**
26 **Payments and Interest Held in Trust on Their Behalf by Wells Fargo Bank", upon the**
27 **effective date of that resolution by deleting the member identified on the Monthly Age**
28 **18 Report Amendment April 2013.**






