

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting August 13, 2013 Special Session to Address the Uniform Election
Ordinance Amendments)**

LEGISLATIVE ORDER NO. 13-322

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,
4 Section 1(a)); and


5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the
7 Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, the Rules Committee has requested a special session on August 13, 2013 to address the
9 Uniform Election Ordinance amendments.

10 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a
11 special session on August 13, 2013 to address the Uniform Election Ordinance
12 amendments.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH day of
14 AUGUST, 2013 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; -0- AGAINST;
15 -0- NOT VOTING; and 224.2[08] ABSENT, pursuant to the powers vested in the Council by Article VI,
16 Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
17 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
18 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
