8	WHEREAS,	$the \ Legislative \ Council\ adopted\ the\ Charter\ of\ the\ Gaming\ Enterprise\ (the\ "Charter")$
9		by Resolution No. 93-311 and amended the Charter by Resolution 02-294, Resolution
10		No. 03-231, and Resolution 04-513 (16 Tohono O'odham Code Chapter 2); and
11	WHEREAS,	the Charter authorizes the Gaming Enterprise, with the prior approval of the
12		Legislative Council, to create a sinking fund for capital expenditures such as
13		$remodeling\ or\ additions,\ equipment\ acquisitions,\ expansion,\ and\ new\ construction$
14		(Charter, Section 7(c)); and
15	WHEREAS,	by Resolution No. 11-428, the Legislative Council authorized the Gaming Enterprise to the Council authorized the Council aut
16		$create\ a\ sinking\ fund\ ("Sinking\ Fund")\ for\ the\ limited\ purposes\ set\ for\ th\ in\ the\ Tohono$
17		O'odham Gaming Enterprise Sinking Fund Proposal; provided that the Legislative
18		Council reserved to itself the authority to approve Sinking Fund expenditures for
19		additional purposes; and
20	WHEREAS,	it is in the Nation's best interest to direct additional Sinking Fund expenditures in
21		accordance with the attached Tohono O'odham Gaming Enterprise Sinking Fund
22		Expenditure Supplemental Authorization, which is incorporated by this reference;
23		and
24	WHEREAS,	$the\ Commerce\ Committee\ and\ the\ Budget\ and\ Finance\ Committee\ have\ reviewed\ the$
25		Tohono O'odham Gaming Enterprise Sinking Fund Expenditure Authorization and
26		recommend its approval.
27	NOW, THER	REFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that, in addition
28		to the purposes set forth in the Tohono O'odham Gaming Enterprise Sinking Fund
29		Proposal, the Gaming Enterprise is directed to expend a portion of the Sinking Fund
30		to pay certain expenses in accordance with the Tohono O'odham Gaming Enterprise
31		Sinking Fund Expenditure Supplemental Authorization, which is approved.
