

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Professional Services Agreement between the Tohono O'odham Nation
and The University of Arizona, Arizona Center on Aging)**

RESOLUTION NO. 13-325

1 **WHEREAS, the Division of Adult Protective Service (APS) was awarded a three year Elder Abuse**
2 **grant from U.S. Administration on Aging beginning October 1, 2012 and ending**
3 **September 30, 2015, and approved by the Tohono O'odham Legislative Council in**
4 **March 2013; and**

5 **WHEREAS, the Scope of Work of the grant is to develop elder abuse training curriculum and**
6 **screening tools and assist in the program evaluation process; and**

7 **WHEREAS, the University of Arizona, Arizona Center on Aging has a working relationship with UC**
8 **Irvin's U.S. Administration on Aging National Center on Elder Abuse Clearinghouse**
9 **and the Center of Excellence on Elder Abuse and Neglect; and**

10 **WHEREAS, the aforementioned agencies have training curricula and materials which will be**
11 **beneficial in developing training material and screening tools for the local level, and**

12 **WHEREAS, Adult Protective Services proposes to contract with the University of Arizona, Arizona**
13 **Center on Aging for development of training materials and screening tools; and**

14 **WHEREAS, any and all training materials and tools developed will be at foremost be culturally**
15 **sensitive to the Tohono O'odham; and**

16 **WHEREAS, any and all training material and tools developed will be reviewed and approved by**
17 **the Department of Health and Human Services management prior to implementation.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
19 **approves Adult Protective Services to contract with the University of Arizona, Arizona**
20 **Center on Aging for development of training materials and screening tools.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials to wit, the Chairperson and**
22 **any designated official is hereby authorized to implement the contract, provided**
23 **however, that any amendments affecting the contract shall be submitted for further**
24 **prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
26 **of AUGUST, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
28 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
