| 3  | WHEREAS, pursuant to Section 12 of the Compact, the Nation agreed to make certain tribal                 |
| 4  | contributions in consideration for substantial exclusivity covenants by the State; and                   |
| 5  | WHEREAS, pursuant to Section 12(d) of the Compact, the Nation agreed to contribute 12% of its            |
| 6  | total annual contribution (the "12% Distribution") to cities, towns, and counties, for                   |
| 7  | services that benefit the general public; and  |
| 8  | WHEREAS, pursuant to Section 12(e)(2) of the Compact the 12% Distribution disbursement shall             |
| 9  | be transmitted to the recipient no later than sixty (60) days after the last day of the                  |
| 10 | Gaming Facility Operator's fiscal year; and  |
| 11 | WHEREAS, the Commerce Committee of the Legislative Council and the Chairman of the Nation                |
| 12 | recommend that the Legislative Council approve awards to grantees for the                                |
| 13 | designated purposes and in the amounts appearing on the 2013 12% Distribution List,                      |
| 14 | which is incorporated herein by this reference.  |
| 15 | NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby adopts                 |
| 16 | the 2013 12% Distribution List and approves payments to the listed grantees for the                      |
| 17 | purposes identified in the 2013 12% Distribution List, which shall remain confidential                   |
| 18 | and shall not be reported or disclosed.  |
| 19 | BE IT FURTHER RESOLVED that the Commerce Committee and Nation's Chairperson are                          |
| 20 | authorized to jointly approve amendments to 2013 12% Distribution List awards that                       |
| 21 | are made exclusively to the grantees identified in the 2013 12% Distribution List, that                  |
| 22 | are solely for purposes permitted under Section 12(d) of the Compact, and that                           |
| 23 | collectively do not exceed 10% of the total Distribution amount.   |
| 24 | BE IT FURTHER RESOLVED that the Nation's Chairperson is authorized to approve grantees                   |
| 25 | ${f requests}$ to ${f spend}$ unused ${f remaining}$ funds identified in the 2013 12% Distribution List, |
| 26 | that are solely for purposes permitted under Section 12(d) of the Compact and that fall                  |
| 27 | within the scope of work identified in the grantee's proposal as approved by Council.                    |
| 28 | BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Chairman               |
| 29 | of the Nation to execute grant agreements with the grantees in accordance with the                       |
| 30 | 2013 12% Distribution List and the terms of this resolution.   |
