

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recessing September 13, 2013 General Session for Mandatory Arizona Indian
Gaming Association Tribal Leaders Meeting at Harrah's Ak-Chin)

LEGISLATIVE ORDER NO. 13-329

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,
4 Section 1(a)); and

5 WHEREAS, Article I, Section 1(A) of the Legislative Rules of the Tohono O'odham Legislative
6 Council, as amended, provides that, "Prior to an official adjournment, the Tohono
7 O'odham Legislative Council ("Legislative Council") shall adopt a legislative calendar"
8 specifying general session dates; and


9 WHEREAS, Article 1, Section 1(A)(2) of the Legislative Rules provides that, "The legislative calendar
10 shall not be changed without Legislative Council approval."; and

11 WHEREAS, the Commerce Committee has requested that the Legislative Council recess the
12 September 13, 2013 general session to attend the Arizona Indian Gaming Association
13 tribal leaders meeting at Harrah's Ak-Chin.

14 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it will recess
15 the September 13, 2013 general session for a mandatory Arizona Indian Gaming
16 Association tribal leaders meeting at Harrah's Ak-Chin, provided that the general
17 session attendance provisions of the Legislative Rules shall apply during the meeting
18 and Legislative Council secretary will take attendance at 9:00 AM without conducting
19 a formal roll call or establishing a quorum.

20 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13TH day of
21 AUGUST, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
23 Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
24 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
25 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
