(Approving an Attorney Contract for FY 2013-2014 with the Law Firm of
Flores Lujan - Bringas Canez)

RESOLUTION NO. 13-330

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of Flores Lujan**
2 **- Bringas Canez in Hermosillo, Sonora, Mexico to represent the Nation in matters**
3 **involving a criminal complaint filed in Hermosillo; and**

4 **WHEREAS, the Attorney General has recommended a total budget of \$15,000 which would be**
5 **available in FY 2013 and FY 2014 for the period from the effective date in August 2013**
6 **to September 30, 2014; and**

7 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**
8 **Attorney General; and**


9 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney**
10 **contract and recommend approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that:**

- 12 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**
13 **law firm of Flores Lujan - Bringas Canez in the total amount of \$15,000.00 for FY**
14 **2013 and FY 2014 for the period from the effective date in August 2013 to**
15 **September 30, 2014, substantially in the form attached hereto.**
- 16 **2. Funding for the Attorney Contract shall be provided from the budget of the Office**
17 **of Attorney General.**
- 18 **3. The Chairperson of the Nation is authorized to execute the Attorney Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
20 **of AUGUST, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
22 **VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
