**RESOLUTION NO. 13-332**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspelling in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 15-82, 67-**  
14 **82,162-82, 16-83, 83-83, 127-83, 06-84, 95-415, 95-518, 96-324, 97-144, 97-256, 97-**  
15 **322, 97-480, 98-123, 98-294, 99-080, 99-140, 99-311, 99-360, 2000-298, 01-004, 01-**  
16 **263, 01-355, 02-280, 05-653, 06-511, 07-075, 07-500, 08-324, 09-369, 10-153 and 13-**  
17 **243 be amended to reflect the correct name spelling or roll numbers for the**  
18 **individuals identified in the Amending Enrollment Resolution List September**  
19 **2013, which is incorporated by this reference; and**

20 **WHEREAS, the Enrollment Program has further determined that two members were**  
21 **erroneously approved twice for membership (one member was originally**  
22 **approved by Resolution No. 01-050 and the second member was originally**  
23 **approved by Resolution No. 08-606); and**

24 **WHEREAS, the Enrollment Program discovered that these same two members were**  
25 **approved a second time in Resolution Nos. 01-416 and 10-352; and**

26 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 01-416 and**  
27 **10-352 be amended to delete the members identified in the Amending**  
28 **Enrollment Resolution List September 2013; and**

29 **WHEREAS, the members who were approved in the Resolution Nos. 01-050 and 08-606 will**  
30 **retain the roll numbers and approval dates identified in those original**  
31 **resolutions.**



15 Council by Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the  
16 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and  
17 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
18 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
