

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 13-068, Approving to add 1 Eligible Minor Member to the Minor**  
**Master Listing for Fourth Per Capita Payment and Authorizing Distribution of Per**  
**Capita Payment and Interest Income to the Eligible Minor Member)**

**RESOLUTION NO. 13-337**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved initiative No. IN-01-97, the**  
2 **"Tohono O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which**  
3 **authorizes per capita payments to the Nation's member provided that sufficient**  
4 **gaming revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono**  
6 **O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize**  
7 **per capita distribution payments in accordance with the Initiative (Legislative**  
8 **Council Resolution No. 97-303); and**

9 **WHEREAS, the Trust Agreement with Wells Fargo Bank requires that a listing of all minor**  
10 **beneficiaries turning 18 that month be presented to the Tohono O'odham**  
11 **Legislative Council to obtain approval to distribute the trust funds to these**  
12 **eligible minor members as they are no longer restricted beneficiaries; and**

13 **WHEREAS, the Tohono O'odham Legislative Council approved to add 1 Eligible Minor**  
14 **Member to the Minor Master Listing for the Fourth Per Capita Payment and**  
15 **Authorizing Distribution of Per Capita Payment and Interest Income to the**  
16 **Eligible Minor pursuant to Resolution No. 13-068; and**

17 **WHEREAS, the Nation's Enrollment Office has identified an incorrect name on a member**  
18 **identified in Resolution No. 13-068; and**

19 **WHEREAS, the Nation's Enrollment Office recommends that the name of the member be**  
20 **amended on Resolution No. 13-068.**


21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
22 **amends Resolution No. 13-068, Approving to add 1 Eligible Minor Member to the**  
23 **Minor Master Listing for the Fourth Per Capita Payment and Authorizing**  
24 **distribution of Per Capita Payment and Interest Income to the Eligible Minor**  
25 **Member, to reflect the correct name of the member in accordance with the**  
26 **attached Amendment September 2013.**


