11		Legislative Council to obtain approval to distribute the trust funds to these					
12		eligible minor members as they are no longer restricted beneficiaries; and

14		Monthly Age 18 Report for June 2012 who reached the age of 18 and is no longer					
15		restricted from receiving their per capita payments in Resolution No. 12-183;
