

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing Amendment 1 of the San Lucy Radio Station Fiscal Year**  
**2013 appropriation; extending authority into FY 2014)**

**RESOLUTION NO. 13-342**

1 **WHEREAS, under Resolution 12-249, Appropriating and authorizing funds for the**  
2 **construction of the San Lucy non-commercial FM radio station (Station) in the**  
3 **amount of \$273,093.53, the Tohono O'odham Legislative Council (Council)**  
4 **appropriated and authorized funds for the construction of the San Lucy Radio**  
5 **Station; and**

6 **WHEREAS, funds were appropriated for the initial operating expenses of the Station which**  
7 **remain unexpended and unobligated due to a delayed start in the construction**  
8 **of the Station; and**

9 **WHEREAS, these operating expenses were included in the administrative budget of Hewel**  
10 **Ni'ok for fiscal year 2014; and**

11 **WHEREAS, the Construction Permit issued to the Tohono O'odham Nation (Nation) from the**  
12 **Federal Communications Commission for the construction of the San Lucy**  
13 **Radio Station is not scheduled to expire until October 30, 2014; and**

14 **WHEREAS, due to the delays in having equipment delivered and installed, it is necessary to**  
15 **extend the appropriation authority in fiscal year 2014; and**

16 **WHEREAS, Hewel Ni'ok staff have prepared an amendment re-allocating the unexpended**  
17 **and unobligated operational expense funds towards capital equipment and site**  
18 **preparation line items as presented in the attached budget amendment; and**

19 **WHEREAS, the budget amendment was presented to the Executive Office, Cultural**  
20 **Preservation and Budget & Finance committees of the Legislature for review**  
21 **and recommend approval.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**  
23 **attached budget amendment for the San Lucy Radio Station is hereby approved**  
24 **and authorized as presented to re-allocate unexpended and unobligated**  
25 **operational expense towards the capital equipment and site preparation line**  
26 **items, this amendment does not change the approved budget \$273,093.53.**

27 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend these**  
28 **funds for the period of October 1, 2013 through September 30, 2014; and the**  
29 **Accounting Department is authorized to post the unexpended balances as of**  
30 **September 30, 2013 of the appropriation as a carry forward into fiscal year 2014**  
31 **beginning October 1, 2013.**

9 **Council by Article VI, Section 1 (d)(2)&(f) of the Constitution of the Tohono O'odham Nation,**  
10 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
11 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
12 **16 of the Act of June 18, 1934 (48 Stat.984).**


