8		potentially available to provide coverage for the communities of Wa:k, San
9		Xavier District and Florence Community, Gu Achi District; and
10	WHEREAS,	the District Councils of both San Xavier and Gu Achi have enacted resolutions
11		supporting the submission of applications to secure Low Power FM licenses to
12		serve the communities of Wa:k and Florence, provided that Hewel Ni'ok will
13		obtain any additional approvals, as may be necessary and required, from the
14		respective District Councils upon the grant of the license.
