

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Chukut Kuk District FY 2014 Budget)**

**RESOLUTION NO. 13-344**

1 **WHEREAS, the Chukut Kuk District Council did meet on August 21, 2013 in San Miguel at**  
2 **which a quorum was present; and**

3 **WHEREAS, the Chukut Kuk District Council did review and approve the FY 2014 budget**  
4 **(October 1, 2013 – September 30, 2014) for Administration and Communities in**  
5 **the amount of \$1,593,331.05 by Chukut Kuk District Council Resolution No. 2013-**  
6 **81; and**

7 **WHEREAS, funding for the Chukut Kuk District FY 2014 budget will come from Gaming**  
8 **Revenues allocated to the Chukut Kuk District in the amount of \$1,144,609.60**  
9 **(Tohono O'odham Legislative Council Resolution No. 13-265); and**

10 **WHEREAS, the remaining amount of \$448,721.45 will be funded from Chukut Kuk District**  
11 **Investment/Savings for a total budget amount of \$1,593,331.05; and**

12 **WHEREAS, the Chukut Kuk District FY 2014 budget was presented to the Legislative Council**  
13 **Budget & Finance Committee for review.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
15 **approves Chukut Kuk District FY 2014 Budget in the amount of \$1,593,331.05**  
16 **and authorizes expenditure of funds for Administration in the amount of**  
17 **\$1,280,528.76 and the communities in the amount of \$312,802.29.**




