

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Michael J. Brown as a Judge Pro Tempore to the Tohono
O'odham Judicial Court)**

RESOLUTION NO. 13-346

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to appoint**
2 **judges to the Tohono O'odham Judicial Court (Constitution of the Tohono**
3 **O'odham Nation, Article VIII, Section 3); and**

4 **WHEREAS, the Legislative Council "may upon the recommendation of the chief judge**
5 **appoint pro tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2,**
6 **Section 1201); and**

7 **WHEREAS, the term of a judge pro tempore "shall be set forth in the resolution of the**
8 **Legislative Council appointing the judge, but in no case shall the term be longer**
9 **than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and**

10 **WHEREAS, the chief judge has submitted Mr. Michael J. Brown's resume, letter of interest,**
11 **and a letter of recommendation for his appointment as a judge pro tempore to**
12 **the Tohono O'odham Judicial Court; and**

13 **WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to**
14 **the Tohono O'odham Judicial Court, has interviewed Mr. Brown and reviewed**
15 **his resume, letter of interest, and the chief judge's letter of recommendation.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
17 **appoints Mr. Michael J. Brown as a judge pro tempore to the Tohono O'odham**
18 **Judicial Court for a six-year term commencing on the effective date of this**
19 **resolution.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
21 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,695.5**
22 **FOR; 251.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
23 **Council by Article VIII, Section 3 of the Constitution of the Tohono O'odham Nation, adopted by**
24 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**
